## Appointment of Program Chief and Medical Director of the Women's and Children's Program

Over the past number of months, management has undertaken an extensive internal and external search for the new Program Chief and Medical Director of the Women's and Children's Program. This important role will play a central role in leading this program through the planning, consolidation and transformation into the new Women's and Children's Hospital. This search has now been completed and management is recommending the announcement of the newly appointed Program Chief and Medical Director to the organization on January 9, 2024. This will serve to complement the timing of broader programmatic changes in January to support the transformation underway for Women's and Children's.

At a special meeting of the Medical Advisory Committee ("MAC") held on December 20, 2023, the recommended appointment of the Program Chief and Medical Director, Women's and Children's Program as outlined in the briefing note (the "Recommended Motion"), was approved. Management is now seeking Board approval of the Recommended Motion <u>prior to</u> the next regularly scheduled Board meeting on January 25, 2024 in order to proceed with the announcement on January 9, 2024.

To ensure continuity of THP's business, on December 21, 2023, voting directors of the Board were presented with an *electronic written resolution* for approval on the Recommended Motion as outlined in the briefing note
