

## **Reportable Energy Usage and Intensity**

By incorporating green conservation into our day-to-day roles, we can contribute to saving money, which in turn can be reallocated to patient care. We recognize the potential environmental impact of our operations and subsequent effect on patients, staff and the community.

The Provincial Government has committed to help public agencies to better understand and manage their energy consumptions. As part of this commitment, Ontario Regulation 507/18: *Broader Public Sector: Reporting and Conservation and Demand Management Plans*, under the Electricity Act, 2009 requires hospitals to report on their energy consumptions and greenhouse gas (GHG) annually.
